An open space management plan was recently completed by Brandywine Conservancy outlining the trail system and other natural features to be included on the parcel.



# **SIGN**REGULATIONS

Spring is almost here and homes are going up for sale. Your realtor should know what the regulations are for posting signs but a refresher is always helpful. Sign pollution can be a problem and the home owner can help with this.

Please note that Off Site directional signs are prohibited. A property can have one ONE sale sign posted on the front lawn unless it is a corner lot in which case it can have two.

Open house signs are permitted ONLY 24 hours before the event and must be taken down within 24 hours after the event.

Illegal signs will be removed and discarded. A realtor can call the Township office at 610-388-7323 with any questions.

# SUMMER ROAD WORK AND REMINDERS

The following roads will be worked on this summer: Stockford Road, Shadow Lane, Spindle Lane, Sparrow Hawk Lane, North Ridge, South Ridge, Honey Tree Lane, Misty Meadow, Independence Way, Hanover Drive and Evergreen Court. Do not plant or place anything in the Township right of way — 5 feet in from the edge of the road should be grass. Also keep trees and bushes trimmed back and out of the road way.

Plantings pose a hazard to the traveling public as well as Township vehicles doing road work.

DRIVEWAY PERMITS are need for resurfacing your drive. This is to make sure the swales at the edge of the road do not allow storm water runoff onto the road which can cause flooding. The permit fee is \$75.00. For questions, contact Roadmaster, Dave Allen at 610-388-9180.

### ❖ REDUCE STORMWATER RUNOFF THIS SPRING

- •Convert a corner of your property to native warm season grasses. Their extensive roots of 3 to 7 feet deep enrich the soil and absorb many times the amount of rainwater that turf does.
- Plant a large stature tree. At maturity they intercept over 1,000 gallons of rainwater each year. Their broad-leaf canopies reduce the force of rain hitting the soil, reducing erosion.
- •When you fertilize the lawn, you're not just fertilizing the lawn. Excess nitrogen and phosphorus from lawn fertilization is frequently a pollutant to streams by fostering the growth of algae which depletes oxygen levels.

### **Planning Commission Update**

**S**ince the last edition of Pennsbury Township News, the Planning Commission (PC) has:

- Concluded its work on the Brenn's two-lot subdivision application with a recommendation that the supervisors approve the request, subject to the conditions contained in Matt Houtman's final review letter. Additionally, the PC recommended that the waiver request submitted by the Brenn be granted. It should be noted that the Historical Commission was extensively involved in the review process for the subdivision application due to the historical significance of the property.
- Following an advisement by FEMA that the township's definition of "new construction" in our flood plain maps required a change, the amendment was drafted by Solicitor, Tom Oeste. A motion to recommend that the supervisors approve the revised definition was passed by the PC.
- Changed the meeting day from Mondays to Tuesdays at 5:00 PM. The 2018 elected officers are: Dennis Smith, Chair; Corinne Murphy, Vice Chair and Jeff Streitel, Secretary. The Historical Commission and Brandywine Battlefield Task Force representative is Lynn Luft and the Kennett Area Regional Planning representative is Jim Ware.

- Following reviews and discussions with the Historical Commission, the Keller's application for a demolition permit for selected historical buildings on their Springdale Farm property was reviewed by the PC and the recommendation was made to allow this to proceed due to the poor and unsafe conditions of the noted buildings. The application was reviewed by the Board of Supervisors.
- With continued leadership from Jim Ware, the PC completed its work on a long term project to provide increased protection of Pennsbury Township's groundwater by unanimously voting to recommend that the supervisors approve amendments to our Zoning Ordinance that were recently drafted by our Solicitor, Tom Oeste and discussed by the PC.
  - Jeff Streitel completed and forwarded to the Board, the PC's 2017 Annual Report.

All residents are welcome to attend Planning Commission meetings which are scheduled for the 2nd and 4th Tuesdays of the month at 5:00 PM and are held at the Township Building.

# New Recycling Building at SECCRA

**S**ECCRA (Southeastern Chester County Refuse Authority) is receiving more recyclables than ever before. The building where small loads were consolidated into tractor-trailer-sized loads was too small to handle the 50+ tons per day of recycling received.

In 2017, SECCRA received a \$250,000 grant from the Pennsylvania Department of Environmental Protection to help defray the cost of a new building to handle the area's recycling. This building, which will fully cost about \$750,000 got started in late 2017 and will begin operation in early 2018.

### **Interesting Recycling Facts**

- When done correctly, you may find you have less trash when done incorrectly recycling becomes trash! To see how to do it correctly, watch a short 2 1/2 minute video at *www.chestercountyswa.org* and click on *recycling*, then *single stream recycling video*.
- Every four years the PA Department of Agriculture offers agricultural businesses and pesticide applicators the opportunity to dispose of unwanted pesticides safely and easily. The program is offered to different counties each year and this year will include Chester County. Called the CHEMSWEEP Program, it is open to eligible applicators, dealers and business.

### Roadside Cleanup

Saturday, April 21

This is a good project for neighborhood groups to clean up the roadside around their homes. It also is a great way for high school students to acquire community service hours.

Vests, gloves and bags will be provided by the Township. Filled trash bags, if left on the roadside, will be picked up by the road crew. Call the Maintenance Garage at 610-388-9180 to leave your location and request supplies.

### Restrictions on Open Burning

Pennsbury Township Zoning Ordinance 162-1911, sets strict limitations on open burning.

- Open burning of anything other than leaves and small branches is strictly prohibited at all times. There shall be no emission of smoke, ash, dust, fumes, vapors, gases, or other matter toxic or noxious to air which violates the Pennsylvania Air Pollution Control Laws.
- Open burning of leaves and small branches is prohibited during the following intervals:

On weekends and Holidays at any time On weekdays between 4:00 PM and 9:00 AM

- Therefore, open burning of leaves and small branches may only be legally conducted during weekdays from 9:00 AM to 4:00 PM at which time the fire shall be fully extinguished.
- Before any legal open burning is conducted, the Longwood Fire Company must be informed in advance and the fire comply with all fire department requirements. It should be noted that approval by Longwood Fire Co is necessary, but not sufficient. The Township regulations must be adhered to regardless of Longwood Fire Co approval.
- Also, Township notices regarding leaf and branch pickup carry the underlying ordinance restriction regarding open burning.

Please be good neighbors and comply with the Township open burning regulations.

# Branch Pickup

Monday - Friday, April 9-13

The road crew will come by only ONCE during the week so have your branches out on Monday. They will not be collected unless they are properly prepared. If you have questions call Roadmaster, Dave Allen, at 610-388-9180.

This program is for residents to get rid of fallen limbs or small trees. IT IS NOT TO BE USED AS A COMMERCIAL TREE SERVICE OR FOR LOT CLEARING.

The Township mulch pile is available for residents' use. Contact Dave Allen to coordinate pickup or with questions.


### Preparation of brush and limbs:

- Brush and limbs must be from your Pennsbury Township property.
- Roots stumps and limbs with wire and/or nails will NOT be picked up.
  - All brush and limbs must be in the right of way.
- Dry, dead brush and tree limbs must be tied in bundles 3' long or less. Each bundle should be not greater than 12" in diameter.
- Fresh-cut (green) limbs, 2" in diameter and larger, should be left full length, placed along roadside with large ends closest to the road, not in a random pile.
- Only 8 bundles of brush and/or tree limbs and 10 fresh cut branches are allowed per property.

This is **FREE** for Pennsbury Township residents and will be held in the Township Building parking lot. **No commercial businesses**.

This is an opportunity for you to shred those important documents that should not be sent to the landfill. Identity theft is everywhere so take this opportunity to dispose of sensitive items properly.
